GIST OF THE COMPLAINT:

The complainant consumer Smt Tulabati Bewa, At: Paria, Po- Cheliamal, Karlapada, Dist. Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has given in writing and submitted during course of hearing at camp court in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute / meter mismatch of his LT/Dom supply with CD of 0.5 KW having consumer No. 9036-1307-0441 under SDO-II, Bhawanipatna.

- The complainant reiterated for excess billing. The OP submitted that the Average bill was served to the consumer from July-2023 to August-2023 due to meter burnt.
- As per billing data base FG, amount of Rs.12090.89 has been withdrawn from complainant account on dtd.12.10.2023.

ORDER 09.01.2024
