The complainant has appeared and submitted during course of hearing at camp court at Bhawanipatna on dt. 16.04.24, in brief as follows:

- 2) As complained by the complainant the abnormal billing was raised from 03/2023 to

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for abnormal billing. The OP submitted that the abnormal/provisional bill were served to the consumer from 01/020 to 11/2022 due to house lock.
- As per billing database the abnormal meter reading was recorded from 03/2023 to 01/2024.
- As per billing database the reason mentioned by MMG the old meter no. 3005554 was replaced due to meter defective & reading jump.

ORDER 11.06.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill from 02/2022 to 01/2024 by taking six-month average consumption of new meter installed on 01/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
