**GIST OF THE COMPLAINT:**

The complainant consumer Sri Budhia Mahakud, Repr. By Sri Saroj Mahakud, At/Po-Duarsuni, Ps-Bhawanipatna, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Naktiguda on dt. 24.07.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- **9036-1309-0368** under EE Elect. SDO No-II, Bhawanipatna.
- 2) As complained by the complainant 5586 unit was served in the month of 10/2024 which is abnormal.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (EE Elect. SDO No-II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 05/08/2025
- 2) Bill details from: 02/2001 to 06/2025
- 3) Date of supply: 01.01.1990
- 4) Category: LT/Domestic
- 5) Connected Load: 1 KW
- 6) Meter No – TWST1785461
- 7) Installed on: 08.11.2024 with IMR "0"
- 8) CMR: 2015 KWH on 05/08/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE Elect. SDO No-II, Bhawanipatna as follows:
  - Disputed bills are revised from Dec-2015 to Apr-2024 is already revised in obedience to the GRF order vide CC No-424/2024. Disputed Oct-2024 is to be considered to



resolve the case. However, the respondent requested the forum to take appropriate decision as necessary.

### **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Disputed bills are revised from Dec-2015 to Apr-2024 is already revised in obedience to the GRF order vide CC No-424/2024. Disputed Oct-2024 is to be considered to resolve the case.
- Abnormal bill was served in the month of 10/2024.
- Meter No. TWST1785461 had been installed on dt. 08.11.2024 and the CMR is "2015" Kwh as on dt. 05.08.2025.

### **ORDER** **30.08.2025**

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.


The OP is directed as follows:

- The bills served on 10/2024 is to be revised by taking average of six consecutive billing of new meter.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by September-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
