#### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Budhia Mahakud, Repr. by Sri Saroj Mahakud, At/Po-Duarsuni, Ps- Bhawanipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Bhawanipatna on dt. 21.10.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no-9036-1309-0368 under SDO Elect. No II, Bhawanipatna.
- 2) As complained by the complainant that 28106 units was billed for the month of 04/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Abnormal provisional / average bills were served to the consumer from 02/2001 to 03/2007 and 08/2007 to 04/2024.
- As per billing database the bill was raised in the month of 04/2024 with high consumption of 28106 units, which seems supress meter reading.

## ORDER 07.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To recast the bill from 12/2015 to 04/2024 with IMR "0" KwH on 12/2015 and FMR "28106" KwH on 04/2024.
- The name of the consumer may be changed as per the guidelines of OERC.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
