GIST OF THE COMPLAINT:

The complainant consumer Sri Sudhansu Sekhar Das Repr. by Kandarpa das, At-Thuapadar, P.O- Duarsuni, Ps- Sadar Bhawanipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Duarsuni on dt. 18.03.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Dom supply with CD of 2 KW having consumer no- 9036-1314-0150 under SDO Elect. No II, Bhawanipatna.
- 2) As complained by the complainant abnormal/average bill was served 08/2007 to 10/2015 & provisional/average bills was served from 02/2018 to 08/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average billing.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for provisional/average billing. The OP submitted that Abnormal/average bill was served to the consumer from 08/2007 to 10/2015 due to without meter and average bill has also served from 02/2018 to 08/2023 due to meter burnt.
- As per data base the provisional bill was served from 10/2018 to 09/2023.

ORDER 14.05.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

➤ To revise the bill from 10/2021 to 09/2023 by taking six months average consumption of present meter (i.e. IMR "1" KwH on 10/2023 and FMR "491" KwH on 03/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
