### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Lambu Kumar, Repr. By Sri Tirtha Kumar, At-Goipita, Po-Thuapadar, Ps-Bhawanipatna, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Naktiguda on dt. 24.07.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9036-1314-0383 under EE Elect. SDO No-II, Bhawanipatna.
- 2) As complained by the complainant defective period from 10/2016 to 12/2020.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE Elect. SDO No-II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE Elect. SDO No-II, Bhawanipatna as follows:
  - Disputed bills from Sept-2017 to Aug-2019 is to be considered to resolve the case.
     However, the respondent requested the forum to take appropriate decision as necessary.

# FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- · The complainant reiterated for excess billing.
- The OP submitted that Disputed bills from Sept-2017 to Aug-2019 is to be considered to resolve the case.
- From 10/2016 to 10/2022 Provisional/Average bills have been served.
- Some bill was served with abnormal meter reading from 11/2008 to 08/2016 due to supress meter reading.
- Meter No. TWST15093619 had been installed on dt. 02.08.2025.

## ORDER 30.08.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- The bills served from 04/2017 to 03/2019 (2 year) are to be revised by taking average of six consecutive billing of meter no-WLT220430.
- To recast the bill from 11/2008 to 08/2016 with IMR "0" KwH on 11/2008 and FMR "6041" KwH on 08/2016.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>September-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
