The complainant consumer Sri Purandhar Majhi, Repr. By Smt Purnami Majhi, At-Padmasagar, Po-Duarsuni, Ps-Sadar Bhawanipatna, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Duarsuni on dt. 18.03.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Dom supply with CD of 2 KW having consumer no- 9036-1314-0447 under SDO Elect. No II, Bhawanipatna.
- 2) As complained by the complainant the abnormal/provisional bill was raised from 04/2015 to 09/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional billing.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for abnormal/provisional billing the OP submitted that Abnormal/provisional bill was served to the consumer from 04/2015 to 09/2023 due to house lock.
- As per billing database the provisional/average bill was raised from 12/2019 to 07/2023.

ORDER 14.05.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

> To revise the bill from 08/2021 to 07/2023 by taking six months average consumption of present meter (i.e. IMR "0" KwH on 09/2023 and FMR "103" KwH on 03/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
