GIST OF THE COMPLAINT:

The complainant consumer Smt. Mira Goud, Repr. by Sri Mukund Goud, At- Goipita, P.O- Thuapadar, Ps- Bhawanipatna, Dist.- Kalahandi comes under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Bhawanipatna on dt. 07.05.24, in brief as follows:

- The complainant has appeared before the forum for revision of provisional bill of his LT/ Dom supply with CD of 2 KW having consumer no- 9036-1314-0449 under SDO Elect. No. II, Bhawanipatna.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. No. II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

 - Abnormal average/ provisional bills were served to the consumer from December 2019 to August 2023 due to defective meter respectively.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

• The complainant reiterated for excess billing. The OP stated that Abnormal average/ provisional bills were served to the consumer from December 2019 to August 2023 due to defective meter respectively.

ORDER 29.07.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

• To revise the bill from May 2021 to April 2023 taking six-month average consumption of new meter install on 06/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
