GIST OF THE COMPLAINT:

The complainant consumer Sri Sanasuta Naik, Repr. By Sri Banti Sahu, At-Sirliguda, Po-Bandelguda Ps-Bhawanipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 28.04.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9036-1314-1081 under EE Elect. SD, No-II, BPT.
- 2) As complained by the complainant the bill was served
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:


To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE Elect. SD, No-II, BPT) in its counter reply and course of hearing submitted as follows:

10) Facts of the complainant: Revision of bill

11) As written version submitted by EE Elect. SD, No-II, BPT as follows:

As per PVR report it is found that, the said consumer's premises has been availing
power supply through a new connection vide SC NO. 9036-1314-3147 in the name of
SANTI DEI and consumer was not availing power supply from Nov-2020 to Jun-2022
through SC NO.9036-1314-1081. Disputed bills from Nov-2020 to Jun-2022 is to be
considered to resolve the case.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per PVR report it is found that, they said consumer's premises has been availing power supply through a new connection vide SC NO. 9036-1314-3147 in the name of SANTI DEI and consumer was not availing power supply from Nov-2020 to Jun-2022 through SC NO.9036-1314-1081. Disputed bills from Nov-2020 to Jun-2022 is to be considered to resolve the case.
- As per billing database provisional bill was served from 12/2019 to 06/2022. As another service connection was released in the month of 10/2020, so the provisional bill raised against SC NO.9036-1314-1081 shall be withdrawn from the period 11/2020 to 06/2022.

ORDER 30.04.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To withdraw the bill from 11/2020 to 06/2022.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>May-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
