#### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Dhanpati Harijan, Repr. by Sri Markanda Harijan, At/Po-Kamthana, Ps- Bhawanipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Naktiguda on dt. 13.03.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 2 KW having consumer no- 9036-1318-0292 under EE, Elect. Sub Division Office, Noi. II, Bhawanipatna.
- 2) As complained by the complainant that bill was served from 12/2018 to 12/2021 without power supply.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

To revise the excess bill.

# SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, Elect. Sub Division Office, Noi. II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 28/03/2025
- 2) Bill details from: 05/2005 to 12/2021



- 4) Category: LT/Domestic
- 5) Connected Load 2 KW
- 6) Meter No TWST15000454
- 7) Installed on: 28/03/2025 with IMR "0"
- 8) CMR: 1 KWH on 28/03/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE, Elect. Sub Division Office, Noi. II, Bhawanipatna as follows:
  - Abnormal provisional bills were served to the consumer from 05/2005 to 12/2021.
  - Disputed bills from 12/2005 to 12/2021 may be considered to resolve the case. As per PVR report submitted by ESO No. III, Bhawanipatna, it is found that the consumer was not availing power supply from 12/2018 to 12/2021, So energy of the said period may be waived.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Abnormal provisional bills were served to the consumer from 05/2005 to 12/2021.
- Disputed bills from 12/2005 to 12/2021 may be considered to resolve the case. As per PVR report submitted by ESO No. III, Bhawanipatna, it is found that the consumer was not availing power supply from 12/2018 to 12/2021.
- As per billing database some bill was served in high consumption meter reading during the period from 12/2014 to 04/2017, which seems supress meter reading.
  And provisional/average bill was served from 05/2017 to 12/2021.

# ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To recast the bill from 12/2014 to 04/2017 with IMR "0" KwH on 12/2014 and FMR "5479 on 04/2017.
- ➤ To revise the bill from 05/2017 to 11/2018 by taking 6 months average consumption of present meter installed on 28.03.2025.
- ➤ To withdraw the bill from 12/2018 to 12/2021 excluding fixed charges.



The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>October-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
