GIST OF THE COMPLAINT:

The complainant consumer Sri Raghunath Mahapatra Repr. by Sri Kanhu Mahapatra, At-Dewansahebpada, Ps/Po- Bhawanipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Naktiguda on dt. 10.01.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9036-1318-0421 under EE, Sub-Division No. II, Bhawanipatna.
- 2) As complained by the complainant that the average bill was served without power supply from 2000 to till date.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, Elect. Sub-Division No. II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

1) PVR: 24/01/2025



2) Bill details from: 03/2001 to 12/2021

3) Date of supply: 01/01/1990

4) Category: LT/Domestic

5) Connected Load 1 KW

6) Meter No – WESCO62294

7) Installed on: 13/12/2002 with IMR "0"

8) CMR: 0 KwH as on 21/01/2025 (No meter at the site)

9) The meter status: Ghost Consumer

10) Facts of the complainant: Revision of bill

11) As written version submitted by EE, Sub-Division No. II, Bhawanipatna as follows:

Dispute bills of no power supply period from 01/2002 to 12/2021 may be treated as
disconnected period as per PVR report submitted by Officer RCM, section no. III
Bhawanipatna, so energy bills of the said period may be considered.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Dispute bills of no power supply period from 01/2002 to 12/2021 may be treated as disconnected period as per PVR report submitted by Officer RCM, section no. III Bhawanipatna, so energy bills of the said period may be considered.
- As per billing database the average bill was served from 03/2001 to 12/2021. The
 Sarapanch has certified that Late Kanhu Charan Mahapatra was residing with his
 from 2000 and expired in the year 2006 and the house was dilapidated condition.
 Prasant Kumar Mahapatra's house is situated adjacent to the house of Late Kanhu
 Charan Mahapatra certified that Late Kanhu Charan Mahapatra was residing from
 2000 who expired on in the year 2006 through affidavit

ORDER 28.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill from 01/2002 to 12/2021 as the consumer was not availing power supply.
- ➤ The complainant is directed to pay the outstanding arrear bill upto 12/2001 along with fixed charges from 01/2002 to 01/2025 as appropriate as per regulation of OERC (if wish to reconnect the power supply).



The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>February-25</u> the opposite party after compliance otherwise it will be treated as non-compliance.
