GIST OF THE COMPLAINT:

The complainant consumer Sri Jugal Kishor Naik, At- Uchhala, Po/Ps- Jaipatna, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Charbahal on dt. 11.03.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 2.5 KW having consumer no- 9040-0102-0350 under EE, KWED Bhawanipatna.
- 2) As complained by the complainant that the bill was generated during the TR burnt period from 03/2022 to 02/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.


SUBMISSION OF OPPOSITE PARTY IN BRIEF:

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that the consumer was billed on OL basis from the date of power supply to 02/2024 as per database.
- As per report of ESO/SDO the transformer of the consumer was burnt from 03/2022 to 02/2024.
- As per billing database the provisional/average bill was served during the period from 11/2013 to 02/2024.

ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To withdraw the bill from 03/2022 to 02/2024, excluding the fixed charges as the transformer was burnt during the above period.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
