- 2) As complained by the complainant that the provisional/average bill was generated from 01/2014 to 11/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.



#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that the consumer was billed on PL basis from 05/2024 to 10/2023 as per database.
- The meter was changed in 11/2023. After meter changed to as on date the bill was on actual basis.
- As per billing database the provisional/average bill was served from 01/2014 to 11/2023.

# ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill from 12/2021 to 11/2023 by taking one-year average consumption of present meter (i.e., IMR "226" KwH on 12/2023 and FMR "1694" KwH on 11/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
