GIST OF THE COMPLAINT:

The complainant consumer Sri Susil Kumar sabar, At-Kusumkhunti, Po- Moter, Ps-Koksara, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during the course of hearing at camp court at Charbahal on dt. 19.02.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation Pumping & Agriculture supply with CD of 2.5 KW having consumer no- **9040-0102-0467** under EE, KWED, Bhawanipatna.
- 2) As complained by the complainant that the provisional bill was served from date of power supply to 12/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KWED, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 04/03/2025
- 2) Bill details from: 03/2018 to 01/2025
- 3) Date of supply: 22/01/2015
- 4) Category: LT/Irrigation Pumping & Agriculture



- 5) Connected Load 2.50 KW
- 6) Meter No – ORU02628
- 7) Installed on: NA
- 8) CMR: NA
- 9) The meter status: No Meter
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE, KWED, Bhawanipatna as follows:
 - The date of power supply of the consumer 22.01.2015.
 - The Consumer was billed on PL basis from the date of power supply to Jan'25 as per database. there after the consumer was in bill stop.
 - As per report of ESO/SDO the consumer was not using the power supply due to theft of LT cable from 01/2019 to 12/2024.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that The Consumer was billed on PL basis from the date of power supply to Jan'25 as per database. there after the consumer was in bill stop.
- As per report of ESO/SDO the consumer was not using the power supply due to theft of LT cable from 01/2019 to 12/2024.
- As per billing database provisional/average bill was served from date of power supply to till date.

ORDER

27.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To install LT cable & new meter immediately in co-operation of MRT.
- To withdraw the bill from 01/2019 to 12/2024 (excluding fixed charges).
- The complainant is directed to pay the balance outstanding bill and security amount as appropriate as per regulation 144 of condition of supply code, 2019 of OERC.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by April-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
