### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Priti Ranjan Mund AT- Budelbandh, P.O- Paruaguda Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at Bhawanipatna on dtd. 29.12.2023 in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 4 KW having consumer No. 9040-0102-0613 under EE, KWED Bhawanipatna.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

- The complainant reiterated for average billing. The OP submitted that the consumer was billed on average basis from June- 2018 to December- 2023.
- As per billing database a new meter has installed in the consumer premises on dtd.17.02.2024.

# ORDER 22.02.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To revise the bill from February-2022 to January-2024 by taking 1 year average consumption of new meter installed on dtd.17.02.2024.
