GIST OF THE COMPLAINT:

The complainant consumer Sri Prahallad Sahu, At/Po- Dhamanpur, Ps- Golamunda, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Dharamgarh on dt. 18.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 1.5 KW having consumer no- 9040-0102-0666 under EE, KWED, Bhawanipatna
- 2) As complain by the complainant the provisional/average bill was served from date of power supply.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KWED, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from: April 2018 to August 2024
- 3) Date of supply: 12/04/2016

4) Category: LT/Irrigation Pumping and Agriculture

5) Connected Load 1.5 KW

6) Meter No - 10045032

7) Installed on: 23/02/2024 with IMR: "0"

8) CMR: 85 KwH as on 03/10/2024

9) The meter status: Ok

10) Facts of the complainant: Revision of bill

11) As written version submitted by EE, KWED, Bhawanipatna as follows:

 The consumer was billed from the date of power supply to January 2024 on provisional basis.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that the consumer was billed from the date of power supply to January 2024 on provisional basis.
- As per PVR report supply was reconnected on 10/11/2023 after payment of Rs.
 2000
- As per billing database the provisional/average bill was served from date of power supply to 02/2024.

ORDER 28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

➤ To revise the bill from 03/2022 to 02/2024 by taking one year average consumption of present meter was installed on 23.02.2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
