GIST OF THE COMPLAINT:

The complainant consumer Sri Bhawani Shankar Naik, At/Po- Gadiajore, Ps- Dharamgarh, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Golamunda on dt. 22.10.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 1.5 KW having consumer no-9040-0102-1286 under EE, KWED Bhawanipatna
- 2) As complained by the complainant that the bill was generated without power supply from 01/2020 to 10/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the false bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KWED Bhawanipatna) in its counter reply and course of hearing submitted as follows:

11) As written version submitted by EE, KWED Bhawanipatna as follows:

• The date of power supply of the consumer is 30.08.2018.

 As per the report of ESO and PVR submitted by ESO also the report of the JE OLIC Dharamgarh the consumer was billed wrongly without using power supply as the borewell was collapsed from 07/01/2020 to 28/10/2024.

• As per report of ESO the new meter was changed, and power supply was given on dtd. 28.10.2024.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for withdraw the bill was generated without power supply.
- The OP submitted that as per the report of ESO and PVR submitted by ESO also the report of the JE OLIC Dharamgarh the consumer was billed wrongly without using power supply as the borewell was collapsed from 07/01/2020 to 28/10/2024.
- As per billing database the provisional/average bill was served from 09/2018 to 10/2024.

ORDER 14.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To withdraw the bill from 01/2020 to 10/2024.

The case is disposed of accordingly.
