

GIST OF THE COMPLAINT:

The complainant consumer Sri Suvendu Kumar Padhan, Repr. By Sri Manas Ranjan Padhan, At/Po-Atigaon, Ps-Junagarh, Dist.- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Junagarh on dt. 22.07.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 1.5 KW having consumer no- 9040-0102-1369 under EE, KWED, Bhawanipatna.
- 2) As complained by the Provisional billing from 01/2022 to 06/2025. Rs.300/- was deposited vide receipt No. B5 9682170 dt. 03.01.2022 for disconnection of power supply but provisional bills were issued till today.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KWED, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the Consumer had dispute regarding bills in disconnected period.
- From 03/2018 to 06/2025 Provisional/ Average bills have been served.
- As written version submitted by SDO (Junagarh) the power supply was disconnected from 01/2022.
- Meter No. TPU009340 had been installed on dt. 31.12.2021.

ORDER

31.07.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- The bills to be withdrawn from 07/2023 to 06/2025.
- The complainant must clear all dues upon revision of bills upto 12/2021.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by August-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
