GIST OF THE COMPLAINT:

The complainant consumer Sri Khetramohan Sahu Repr. by Sri Sambhu Prasad Sahu, At/Po- Kaudola, Ps- Ampani Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Koksara on dt. 21.01.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 4 KW having consumer no- 9040-0102-1484 under EE, KWED, Bhawanipatna.
- 2) As complained by the complainant that the bill was raised though there was no power supply due to theft of cables from 11/2018 to 04/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:


To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, KWED, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 3) Date of supply: 05/08/2018

- 5) Connected Load 4 KW.
- 6) Meter No 10055072
- 7) Installed on: 12/05/2024 with IMR "365.75"
- 8) CMR:NA
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE, KWED, Bhawanipatna as follows:
 - The consumer was billed on average basis from the date of power supply to 04/2024.
 - The meter changed on 12/05/2024.
 - The consumer was bill on AC basis from date of meter changed to 12/2024.
 - As per repot from ESO the bill may be withdrawn excluding FC from 11/2018 to 04/2024 due to stolen of motor.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that the consumer was billed on average basis from the date of power supply to 04/2024.
- The meter changed on 12/05/2024.
- The consumer was bill on AC basis from date of meter changed to 12/2024.
- As per billing database average/provisional bill was served to the complainant from 11/2018 to 11/2023. As the complainant has submitted a FIR report that the cable was stollen on 16.11.2018.

ORDER

31.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To withdraw the bill excluding the fixed charges from 11/2018 to 11/2023 due to stollen of cable.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>February-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
