GIST OF THE COMPLAINT:

The complainant consumer Sri Swadesh Kumar Pattjoshi, At- Telipalash Po-Tambachhada, Ps-Dharamgarh, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Dharamgarh on dt. 19.03.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Irrigation supply with CD of 4 KW having consumer No **9040-0102-2050** under EE, KWED, Bhawanipatna.
- 2) As complained by the complainant the provisional bill has raised without power supply.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the provisional bill.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for provisional billing. The OP submitted that As per PVR dtd.16.02.2024 it is stated by ESO No-II Dharamgarh that the site has verified and found that the consumer power supply is not charge till date from supply release date.
- The District Manager OAIC Ltd, Kalahandi has intimated that the LI point of Swadesh Kumar Patjoshi has not charged till date, vide his letter no. 1056, dtd.06.02.2024.

ORDER

30.05.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill from 08/2021 to 04/2024 & stop the bill generation till charging of power supply.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
