GIST OF THE COMPLAINT:

The complainant consumer Sri Golap Singh Thakur, At- Gantayatpada, Po/Ps- Junagarh, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Junagarh on dt. 10.03.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1.5 KW having consumer no- 9042-4103-0211 under EE, I/C SDO Elect. Junagarh
- 2) As complained by the complainant that excess bill was served in the month of 07/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, I/C SDO Elect. Junagarh) in its counter reply and course of hearing submitted as follows:

2) Bill details from: 02/2013 to 02/2025

- 4) Category: LT/Domestic
- 5) Connected Load 1.5 KW
- 6) Meter No LW618976
- 7) Installed on: 29/08/2021 with IMR "0"
- 8) CMR: 20920 KWH on 28/03/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE, I/C SDO Elect. Junagarh as follows:
 - Consumer had dispute regarding high bill in between 08/2021 to 01/2025 and IMR was punched wrongly in database of current meter.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Consumer had dispute regarding high bill in between 08/2021 to 01/2025 and IMR was punched wrongly in database of current meter.
- As per billing database the meter was changed on 04/2021 but provisional bills were served for some months and 963 units was served in the month of 07/2023 which seems to be suppressed meter reading.

ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 08/2021 to 01/2025 by taking IMR "0" kwh on 08/2021 and FMR "20534" kwh on 01/2025.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> the opposite party after compliance otherwise it will be treated as non-compliance.
