The Complainant Sri Bijeadra Khiti (Represented by Surendra Khiti) appeared before the Forum during the camp court held at Junagarh on dt. 21/11/2023, aggrieved by sudden raised in bill amount by Rs 26662.23 in the month of July-2023.

SUBMISSION OF COMPLAINANT DURING HEARING:

The complainant reiterated his complaint regarding the sudden rise in bill amount in the month of 07/2023. He requested to revise the bill.

SUBMISSION OF OPPOSITE PARTY DURING HEARING:

The OP (SDO Junagarh) has submitted the following documents:

- a) A written Statement, stated that:
 - > Consumer has bill dispute regarding old meter final reading of 10884 kwh.
- b) PVR Dtd. 08/12/2023 was submitted mentioning meter number as TWSP51018782 and CMR as "558".

OBSERVATIONS OF THE FORUM

From the database and statement as submitted by SDO(Elect.) Junagarh, the Forum observed that an amount of Rs26662.23 was debited into consumer account in the month of July-2023 against 10884 units, which was found as suppress reading, while BEFORE MERCENCE FOREST

changing the old meter with a new smart meter make both of August-2023. The old meter was installed in the consumer premises since date of supply. The consumer was also aggrieved for such high billing in a single month, which was served to him.

ORDER 29.12.2023

Based on the above observations, the Forum passes the following order as per regulations 155 of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast and spread over the amount, debited in the month July-2023, from date of supply to May-2023 and to be charged from January-2021 onwards on prorate basis withdrawing the rest amount.

Case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
