#### **GIST OF THE COMPLANT:**

The Complainant Sri Tankadhar Durga (Represented by Rukman Durga) appeared before the Forum during the camp court held at Junagarh on dt. 21/11/2023, aggrieved by abnormal reading recorded by meter from 06/2022 to 09/2022.

#### SUBMISSION OF COMPLAINANT DURING HEARING:

The complainant reiterated his complaint regarding abnormal reading recorded by meter from 06/2022 to 09/2022 in comparison to the present consumption pattern.

#### SUBMISSION OF OPPOSITE PARTY DURING HEARING:

The OP (SDO Junagarh) has submitted the following documents:

- a) A written Statement, stated that:
  - Consumer has disputed regarding bill between months 07/2022 to 09/2022.
- b) PVR Dtd. 11/12/2023 was submitted mentioning meter number as TPWODL1113421 and CMR as "469".

#### **OBSERVATIONS OF THE FORUM**

INDER WAR ICKNOWN

From the database and statement as submitted by SDO(Elect.) Junagarh, the Forum observed that the consumer was billed with abnormally high units from 06/2022 to 09/2022. A new meter was installed on 12/10/2022 and the consumption recorded by meter since then is up to the satisfaction of the consumer.

# ORDER 01.01.2024



Based on the above observations, the Forum passes the following order as per regulations 155 of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill from 06/2022 to 09/2022 basing upon six-month average consumption of the new meter taking IMR as "68" on March-2023 and FMR as "399" on August-2023.

Case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
