GIST OF THE COMPLAINT:

The complainant consumer Sri Pabitra Majhi, Repr. By Sri Khetra Majhi, At-Kupagaon, Po-Malgundi, Ps-Junagarh, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Junagarh on dt. 08.08.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/DOM supply with CD of 1.50 KW having consumer no- **9042-4212-0312** under SDO Elect. Junagarh.
- 2) As complained by the complainant that actual bill served from 12/2013 to 01/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Junagarh) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 14/08/2025
- 2) Bill details from: 01/2014 to 07/2025
- 3) Date of supply: 21.12.2013
- 4) Category: LT/DOM
- 5) Connected Load 1.50KW
- 6) Meter No – TWB313154
- 7) Installed on: 28.06.2024 with IMR "0"
- 8) CMR: 571 KWH on 14/08/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Junagarh as follows:
 - Consumer has dispute regarding high bills between 12/2013 to 01/2022. However, the respondent requested the forum to take appropriate decision as necessary.



FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Consumer has dispute regarding high bills between 12/2013 to 01/2022.
- Some bills was served in high consumption meter reading during the period from 12/2013 to 01/2022 due to suppress meter reading.
- Meter No. TWB313154 had been installed on dt.28.06.2024.

ORDER

30.07.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- Bill to be recasted from 12/2013 to 01/2022 with IMR "0" Kwh on 12/2013 and FMR "5263" Kwh on 01/2022.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by September-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
