GIST OF THE COMPLAINT:

The complainant consumer Smt. Margasira Jagat, AT- Sanyasikundamal, Po-Mahichala, Ps- Junagarh, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Junagarh on dt. 11.07.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.04 KW having consumer no- 9042-4308-0628 under SDO Elect. Junagarh.
- 2) High bill in between the months from June 2022 to April 2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Junagarh) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from October 2018 to July 2024



- 4) Category: LT/Domestic
- 5) Connected Load 0.04 KW

- 7) Installed on 25/10/2023 with IMR: "0"

- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill

As written version submitted by SDO Elect. Junagarh as follows:

High bill in between the months from June 2022 to April 2023.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that high bill in between the months from June 2022 to April 2023.
- As per database it seems that the accumulated reading have been billed with in a short spam of period i.e from Nov-2021 to Feb-2023, causing erratic billing

ORDER 31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To recast the bill from 10/2018 to 03/2023 with IMR "0" & FMR "8442" to extend the tariff benefit to complaint.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
