GIST OF THE COMPLAINT:

The complainant consumer Pera Kata Repr. by Sri Shyam Kata, At/Po- Rengasapali, Ps-Golamunda Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Junagarh on dt. 18.02.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.04 KW having consumer no- 9042-4318-0499 under EE, Elect. I/C SDO Junagarh.
- 2) As complained by the complainant that abnormal excess bill was served in the month of 04/2022 and 03/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

The OP (EE, Elect. I/C SDO Junagarh) in its counter reply and course of hearing submitted as follows:

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Consumer has dispute regarding high bill in between 03/2018 to 08/2023 and average bills from 08/2023 to 05/2024.
- As per billing database 1854 units and 1848 units were bills for the month of 04/2022 and 03/2023, respectively which seems to be suppressed meter reading.

ORDER

28.02.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To recast the bill from 03/2018 to 08/2023 by taking IMR "0" kwh on 03/2018 and FMR "4693" kwh on 08/2023.
- To revise the bill from 09/2023 to 05/2024 by taking IMR "0" kwh on 06/2024 and FMR "60" kwh on 11/2024.
- ➤ To withdraw the earlier bill revision on date 02/09/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by March-25 the opposite party after compliance otherwise it will be treated as non-compliance.
