**GIST OF THE COMPLAINT:**

The complainant consumer Sri Pustam Naik, Repr. by Sri Phakir Patel, At/Po- Paruaguda, Ps- Kalampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kalampur on dt. 07.01.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- **9042-4402-0013** under EE, Elect. I/C Sub-Division Junagarh.
- 2) As complained by the complainant that abnormal excess bill was served in the month of 09/2014.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (EE, Elect. I/C Sub-Division Junagarh) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from: 02/2001 to 12/2024



- 3) Date of supply: 01/01/1990
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No – TWSP51061316
- 7) Installed on: 27/10/2023 with IMR "0"
- 8) CMR: 109 Kwh as on 27/01/2025
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE, Elect. I/C Sub-Division Junagarh as follows:
  - Consumer has dispute regarding average bill not adjusted in between 03/2016 to 03/2021 but reading correction was made.

### **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Consumer has dispute regarding average bill not adjusted in between 03/2016 to 03/2021 but reading correction was made.
- As per billing database some provisional/average basis bill was raised during the period 03/2014 to 06/2023.

### **ORDER**

**28.01.2025**

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.


The OP is directed as follows:

- To recast the bill from 02/2016 to 01/2021 with IMR "4397" KWH on 02/2016 and FMR "6280" Kwh on 01/2021.

The case is disposed of accordingly.
