

GIST OF THE COMPLAINT:

The complainant consumer Sri Balaram Majhi, At- Paruaguda, P.O/Ps- Kalampur, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kalampur on dt. 08.05.24, in brief as follows:

- 1) The complainant has appeared before the forum for disputing the abnormal billing done from 10/2022 to 10/2023 of his LT/ Dom supply with CD of 0.04 KW having consumer no 9042-4402-0128 under SDO Elect. Junagarh.
- 2) The complainant has intimated the same to the OP earlier verbally, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Junagarh) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from May 2013 to April 2024

- 9) Facts of the complainant: High bill

As written version submitted by SDO Elect. Junagarh as follows:

• Consumer has dispute regarding high bill in the month of 09/2022 and 10/2023.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that consumer has dispute regarding high bill in the month of 09/2022 and 10/2023.
- As per database abnormal bill has been revised up to 02/2023 with a credit sundry of Rs 39219.90/- on dt 21/03/2023.
- But unfortunately, F-code billing was not corrected thereafter and abnormal bills were served to the consumer for the period from 03/2023 to 10/2023.

ORDER 28.06.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

 To revise the bill from 03/2022 to 10/2023 by taking six-month average consumption of new meter IMR "0" as on 11/2023 and FMR "290" as on 04/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
