GIST OF THE COMPLAINT:

The complainant consumer Sri Goura Patel Repr. by Sri Gobinda Patel , At- Tuturaguda, Po- Paruaguda, Ps- Kalampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kalampur on dt. 05.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1.0 KW having consumer no- 9042-4403-0019 under SDO Elect. Junagarh.
- 2) As complained by the complainant that the provisional/average bill was served 09/2015 to 09/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

To revise the provisional/average bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Junagarh) in its counter reply and course of hearing submitted as follows:

10) Facts of the complainant: Revision of bill

11) As written version submitted by SDO Elect. Junagarh as follows:

 Consumer has dispute regarding suppress units spread between 09/2022 to 07/2023 of 4013 units and 1443 units respectively.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Consumer has dispute regarding suppress units spread between 09/2022 to 07/2023 of 4013 units and 1443 units respectively.
- As per billing database some bill was raised in high consumption reading from 09/2015 to 09/2023, which seems supress meter reading.
- As per billing databse bill revision towards adjustment was take in place from 09/2022 to 07/2023, effect on dtd. 18.08.2023.

ORDER 28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 09/2015 to 09/2023 with IMR "0" KwH on 09/2015 & FMR "9304" KwH on 09/2023
- To withdraw the earlier bill revision effect on dtd. 18.08.2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
