#### GIST OF THE COMPLAINT:

The complainant consumer Sri Haldhar Naik, At- Tentulikhunti, Po- Poruaguda, Ps- Kalampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kalampur on dt. 12.11.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9042-4403-0277under SDO Elect. Junagarh.
- 2) As complained by the complainant that bill was served in high consumption meter reading.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Junagarh) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 27/11/2024
- 2) Bill details from: 03/2013 to 10/2024
- 3) Date of supply: 13.03.2013
- 4) Category: LT/Domestic





- 5) Connected Load 1 KW
- 6) Meter No TWSP51062228
- 7) Installed on: 21.10.2023 with IMR: "0" 8) CMR: 2547 KwH as on 27/11/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Junagarh as follows:
  - Consumer has dispute regarding high bill but that caused due to non-payment bill is ok there is no scope for revision.

## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Consumer has dispute regarding high bill but that caused due to non-payment bill is ok there is no scope for revision.
- · As per billing database some bill was raised in high consumption meter reading from 11/2013 to 09/2022, which seems supress meter reading. And the bill was revised from 10/2022 to 09/2023 towards delay meter updating.

## ORDER 16.12.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 11/2013 to 09/2022 with IMR "0" KwH on 11/2013 and FMR "5078" KwH on 09/2022.
- > To test the meter within 7 days of deposit of meter testing fees by complainant. Also to provide meter test report to consumer along with a copy to this forum.
- > The complainant is directed to deposit the meter testing fees as appropriate at concern section office within 7 days of receipt of the order. And again approach to this forum for necessary relief, if found to be faulty.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
