GIST OF THE COMPLAINT:

The complainant consumer Sri Gopal Chandra Rout, At-Patrabasa, Po-Pandigaon, Ps-Kalampur, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Junagarh on dt. 08.08.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/DOM supply with CD of 1 KW having consumer no- 9042-4404-0120 under SDO Elect. Junagarh.
- 2) As complained by the complainant that actual bill served from 09/2016 to 02/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Junagarh) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from: 02/2001 to 07/2025
- 3) Date of supply: 01.01.1990
- 4) Category: LT/DOM
- 5) Connected Load 1 KW
- 6) Meter No TWB335749
- 7) Installed on: 25.03.2024 with IMR "0"
- 8) CMR: 2103 KWH on 14/08/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Junagarh as follows:
 - Consumer has disputed regarding high bills in the month of 10/2022. However, the respondent requested the forum to take appropriate decision as necessary.



On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Consumer has disputed regarding high bills in the month of 10/2022.
- Some bill was served with high consumption meter reading during the period from 09/2016 to 02/2023 due to supress meter reading.
- Meter No. TWB335749 had been installed on dt. 25.03.2024 and the CMR is "2103" KWH on 14/08/2025

ORDER 30.08.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > The bill to be recasted from 09/2016 to 02/2023 with IMR "0" KwH on 09/2016 and FMR "15220" KwH on 02/2023.
- Any bill revision done earlier during this period may be taken into consuderation.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by September-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
