GIST OF THE COMPLAINT:

The complainant consumer Sri Pabitra Mohan Dandasena, Repr. by Sri Upendra Dandasena At/Po- Kalampur, Ps- Kalampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kalampur on dt. 07.01.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/General Purpose supply with CD of 0.50 KW having consumer no- 9042-4405-0141 under EE, Elect. I/C Sub-Division Junagarh.
- 2) As complained by the complainant that the provisional/average bill was served during the period from 03/2019 to 12/2024. And change the category.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, Elect. I/C Sub-Division Junagarh) in its counter reply and course of hearing submitted as follows:

- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE, Elect. I/C Sub-Division Junagarh as follows:
 - Consumer has dispute regarding bills prior to meter change i.e 09/2015 to 01/2019.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Consumer has dispute regarding bill prior to meter change i.e. 09/2015 to 01/2019.
- As per billing database some bill was raised in high consumption meter reading during the period from 03/2019 to 12/2024. Which seems supress meter reading.
 And as per PVR the power supply was used for domestic purpose.

ORDER 28.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 02/2019 to 12/2024 with IMR "0" KwH on 03/2019 and FMR "5764" KwH on 12/2024.
- > To change the category from LT/GP to LT/Domestic with immediate effect.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>February-25</u> the opposite party after compliance otherwise it will be treated as non-compliance.
