GIST OF THE COMPLAINT:

The complainant consumer Smt. Babita Bag, Repr. by Sri Kamal Bag, At- Bankapala, Po-Deypur, Ps- Kalampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Junagarh on dt. 10.12.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9042-4408-0736 under SDO Elect. Junagarh.
- 2) As complained by the complainant that he has availing power supply as Sobhagya category consumer.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

11) As written version submitted by SDO Elect. Junagarh as follows:

Consumer has dispute regarding higher slab bill due to wrong supply date.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Consumer has dispute regarding higher slab bill due to wrong supply date.
- The JE has furnished PVR the supply was release on 16.06.2019.

ORDER 27.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To recast the bill from 06/2019 to 11/2024 by taking IMR "0" KwH on 06/2019 and FMR "11935" KwH on 11/2024.
- To withdraw the bill revision done and debited on dt.21.02.2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by February-25 the opposite party after compliance otherwise it will be treated as non-compliance.
