GIST OF THE COMPLAINT:

The complainant consumer Sri Trinath Kumar, At- Bankapala, Po- Deypur, Ps- Kalampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kalampur on dt. 07.01.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9042-4408-0822 under EE, Elect. I/C Sub-Division Junagarh.
- 2) As complained by the complainant that abnormal excess bill was served in the month of 02/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

Consumer has dispute regarding high bill in the month of 02/2023.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Consumer has dispute regarding high bill in the month of 02/2023.
- As per billing database some bill was raised provisional basis during the period from 01/2021 to 06/2023. And bill revision adjustment was taken in place for the period from 09/2022 to 01/2023, effect on dtd. 21.02.2023.

ORDER 28.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 01/2021 to 06/2023 with IMR "0" KwH on 01/2021 and FMR. "4649" KwH on 06/2023.
- To withdraw the earlier bill revision effect on dtd.21/02/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by February-25, the opposite party after compliance otherwise it will be treated as non-compliance.
