- As per billing database the meter no LW215262 was change on 29.08.2021 with IMR "865" KwH. But again, the same meter no was punched in billing database in 12.09.2021 with IMR "911" KwH.

ORDER 11.06.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

➤ To revise the bill from 08/2019 to 07/2021 by taking six months average consumption of present meter (i.e. IMR "865" KwH on 08/2021 and FMR "1134" KwH on 01/2022).

The case is disposed of accordingly.
