GIST OF THE COMPLAINT:

The complainant consumer Sri Batakrushna Behera, At/Po-Bagad, Via-Dharamgarh, Dist.- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Dharamgarh on dt. 15.10.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9043-4105-0343 SDO Elect. Dharamgarh.
- 2) As complained by the complainant that some abnormal bills were served in the month of 10/2006 and 01/2009.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 16.10.2025
- 2) Bill details from: 04/2003 to 09/2025
- 3) Date of supply: 07.03.2003
- 4) Category: LT/Domestic
- 5) Connected Load: 1 KW
- 6) Meter No – TWSP51186772
- 7) Installed on: 25.05.2024 with IMR "0"
- 8) CMR: 5665 KWH on 16.10.2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Dharamgarh as follows:
 - Billing was average from 12/2004 to 02/2006 and average from 03/2016 to 02/2017. A new meter is installed on 05/2024 and billing is actual till now. However, the respondent requested the forum to take appropriate decision as necessary.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Billing was average from 12/2004 to 02/2006 and average from 03/2016 to 02/2017. A new meter is installed on 05/2024 and billing is actual till now.
- Some bill was served abnormally from 03/2003 to 12/2003 due to suppressed meter reading.

ORDER

30.10.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 03/2003 to 12/2023 with IMR "0" KwH and FMR "9989" KwH.
- Any adjustments made during the revision period are also to be taken into consideration / DPS charged on the wrong bills are also to be withdrawn.
- The complainant must clear all dues upon revision of bills.

The case is disposed of accordingly.

The matter is closed herewith. The compliance report to be submitted to the undersigned on or before **Dt- 30.11.2025**.
