GIST OF THE COMPLAINT:

The complainant consumer Sri Tushar Kumar Pattjoshi, Repr. by Sri Basudev Sahu, At/Po-Dharamgarh, Ps- Dharamgarh, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Dharamgarh on dt. 19.11.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/General Purpose supply with CD of 2 KW having consumer no- 9043-4105-0613 under SDO Elect. Dharamgarh.
- 2) As complained by the complainant abnormal excess bill was served in the month of April 2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:

• Billing was actual from date of connection and a new meter was installed on 25/05/2024 and billing is actual till now and 31286 units billed on 04/2024.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Billing was actual from date of connection and a new meter was installed on 25/05/2024 and billing is actual till now and 31286 units billed on 04/2024.

ORDER 30.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

➤ To revise the bill from 05/2023 to 04/2024 by taking six-month average consumption of new meter installed on 25/05/2024 (excluding the period of supply disconnection).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
