The complainant consumer Sri Padma lochan Patra AT/po- Dharamgarh, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has given in writing and submitted during course of hearing at camp court in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute /double account number in same meter No of his LT/Dom supply with CD of 2 KW having consumer No. 9043-4106-0828 and Con No 9043-4106-0828 under SDO Elect. Dharamgarh.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:

Fact of the complainant: The consumer getting double bill in a single service connection & single meter.

 As per PVR of ESO-I, Dharamgarh the meter WLT224144 is in two consumers and two bills are generated in the name of Padma lochan Patra. Vide consumer nos. 9043-4106-0828 & 9043-4106-0842.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated to withdraw the false bill. The OP submitted that, as per PVR of ESO-I, Dharamgarh the meter WLT224144 is in two consumers and two bills are generated in the name of Padma lochan Patra. Vide consumer nos. 904341060828 & 904341060842.
- As per billing data base 2 numbers of bills are generated in the name of Padma lochan Patra bearing consumer numbers 9043-4106-0828 and 9043-4106-0842 in a single meter bearing sl no. WLT224144.
- In the SC no. 9043-4106-0828 bill has generated on actual basis from date of supply & in the SC no. 9043-4106-0842 the bill was generated in provisional basis from date of power supply.
- As per PVR report of ESO-I, Dharamgarh the FMR is "2453" KwH on dtd. 07.12.2023 against SC no. 9043-4106-0828.

ORDER 01.02.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To withdraw the bill against SC no. 904341060842 from date of power supply (i.e.22.09.2021). And mark the SC no as duplicate.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
