#### **GIST OF THE COMPLAINT:**

The complainant consumer Late Appala Mangaraj repr. by Madhusmita Mangaraj, At-Badbasul, Po-Rahurahaldi, Ps-Dharamgarh, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during the course of hearing at camp court at Dharamgarh on dt. 22.04.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9043-4108-0189 under SDO Elect. Dharamgarh.
- 2) As complained by the complainant the average bill was issued during working in outside the state.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.



11) As written version submitted by SDO Elect. Dharamgarh as follows:

Billing was average Jan-2016 to May-2021 and meter was installed on Jun-2021 billing
was average from Oct-2021 to Aug-2020., Again a new meter was installed on 22-012025 and billing is actual till now. After field verification it was found that the said
premises was locked, and the line was disconnected from Jan-2016 to Dec-2020.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- · The complainant reiterated for excess billing.
- The OP stated that Billing was average Jan-2016 to May-2021 and meter was installed on Jun-2021 billing was average from Oct-2021 to Aug-2020., Again a new meter was installed on 22-01-2025 and billing is actual till now. After field verification it was found that the said premises was locked, and the line was disconnected from Jan-2016 to Dec-2020.
- As per billing database some bill was served in high consumption meter reading during the period from 06/2008 to 12/2015, which seems supress meter reading, and the average bill was served from 01/2016 to 08/2022.

## ORDER 30.04.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To recast the bill from 06/2008 to 12/2015 taking IMR "0" KwH on 06/2008 and FMR "6875" KwH on 12/2015.
- To withdraw the bill excluding the fixed charges from 01/2016 to 08/2022.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>May-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
