**GIST OF THE COMPLAINT:**

The complainant consumer Smt. Laxmi Bewa repr. by Sri Laxman Bag, AT- Godbhanja, Po- Chhilipa, Ps- Dharamgarh, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Dharamgarh on dt. 10.07.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1.5 KW having consumer no- **9043-4110-0053** under SDO Elect. Dharamgarh.
- 2) As complained by the complainant the provisional/average billing was served from 04/2016 to 12/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from October 2005 to June 2024
- 3) Date of supply 10/08/2005
- 4) Category: LT/Domestic
- 5) Connected Load 1.5 KW
- 6) Meter No – TWB647744
- 7) Installed on 10/02/2024 with IMR: N/A
- 8) CMR: 358 Kwh as on 08/08/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Dharamgarh as follows:
  - The consumer is complaining about bill revision during the average periods from 04/2016 to 12/2023 as a new meter was installed on 10/02/2024 and billing is actual from 02/2024 to till now.

#### **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for provisional/average billing. The OP submitted that the consumer is complaining about bill revision during the average periods from 04/2016 to 12/2023 as a new meter was installed on 10/02/2024 and billing is actual from 02/2024 to till now.
- As per billing database the provisional/average bill was served from 04/2016 to 12/2023.

#### **ORDER**

**31.08.2024**

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 01/2022 to 12/2023 by taking six-month average consumption of present meter (i.e. IMR "0" Kwh on 01/2024 and FMR "309" Kwh on 06/2024).


The case is disposed of accordingly.
