The complainant consumer Sri Patra Chandan, Repr. By Sri Benudhar Chandan, At/Po- Brahmanchhendia, Ps- Dharamgarh, Dist.- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Dharamgarh on dt. 19.03.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1.5 KW having consumer No **9043-4202-0260** under SDO, Elect. Dharamgarh.
- 2) As complained by the complainant provisional/average bill was raised from 02/2019 to 08/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that the consumer is complaining about bill revision.
- As per billing database due to supress reading some abnormal bill was raised from 05/2018 to 01/2023 & average bill was raised from 02/2023 to 08/2023.

ORDER 30.05.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill by way of recasting from 05/2018 to 01/2023with IMR "3712" Kwh on 05/2018 & FMR "7500" KwH on 01/2023.
- To revise the bill from 02/2023 to 08/2023 by taking six-month average consumption of present meter (i.e. IMR "0" KwH on 09/2023 & FMR "210" KwH on 02/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
