GIST OF THE COMPLAINT:

The complainant consumer Sri Sanurjaya Chalan, At- Khanatara Po- Tambachhada, Ps- Dharamgarh, Dist.- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Dharamgarh on dt. 19.03.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1.50 KW having consumer No **9043-4204-0022** under SDO Elect. Dharamgarh.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:

- 2) Billing Abstract from February 2001 to September 2021
- 3) Date of supply 01/01/1990
- 4) Category: LT/ Domestic
- 5) Connected Load 1.50 KW



- 6) Meter No- No Meter
- 7) Date of installation of meter: Not mention.
- 8) Fact of the complainant: Revision of previous bill
- 9) As per written version submitted by SDO Elect. Dharamgarh, there are no meter on said premises and supply was disconnected since November 2019 and the premises is in damage condition.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

The complainant reiterated for revision of previous bill. As per OP stated that There
is no meter on said premises and supply was disconnected since November 2019
and the premises is in damage condition. As per data base, bill generation stopped
from billing month of Oct-Nov 2019.

ORDER 28.06.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

In absence of meter in the said premises and final meter reading there off, and non-submission valid document like M/R of D/C fees or receive copy of intimation given to the department regarding supply disconnection by the complainant, forum feels that it is not appropriate to issue any order either for any bill revision or with drawl of EC bill so claimed by complainant.

The case is hereby dropped.
