The complainant has appeared and submitted during course of hearing at camp court at Dharamgarh on dt. 19.03.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD .04 KW having consumer No 9043-4209-0493 under SDO Elect. Dharamgarh.
- 2) As complained by the complainant abnormal bill was raised during 05/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that the consumer is complaining about bill revision.
- As per billing database the provisional/average bill was served from 03/2016 to 04/2023.
- As per billing database bill revision was done twice for the period of 05/2018 to 04/2023 effect on dtd. 03.06.2023 & 05/2018 to 02/2024 yet to be approved.

ORDER 30.05.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill by way of recasting from 09/2015 to 04/2024 with IMR "0" KwH on 09/2015 and FMR "2601" KwH on 04/2024.
- ➤ To withdraw the earlier bill revision was effect on 03.06.2023 & 05/2018 to 02/2024 yet to be approved.

The case is disposed of accordingly.
