GIST OF THE COMPLAINT:

The complainant consumer Sri Januram Mahanand, At/Po- Dharamgarh, Ps- Dharamgarh, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Dharamgarh on dt. 19.11.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1.50 KW having consumer no- 9043-4213-0075 under SDO Elect. Dharamgarh.
- 2) As complained by the complainant that the bill was raised during the disconnection period from 2008, and the premises was demolised.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the bill was raised during disconnection period.

The OP (SDO Elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:

 - As per inquiry report it was disconnected since 2008 and there was no connection till now.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per inquiry report it was disconnected since 2008 and there was no connection till now.
- As per billing database the complainant was paid Rs. 2000/- on dtd. 27.05.2011 towards EC Bill, which construe that the complainant was using power supply till 05/2011. From 06/2011 to 09/2021 the meter status appears premises locked/PDC. And, the bill was stopped from 10/2021 to 09/2024.

ORDER 30.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- ➤ To withdraw the bill from 06/2011 to 09/2021, as the complainant was not availing power supply.
- > The complainant is directed to pay the outstanding EC bill till 05/2011.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
