GIST OF THE COMPLAINT:

The complainant consumer Sri Sunil Kumar Nag, At-Turihaldi, Po- Gadiajore, Ps- Dharamgarh, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Dharamgarh on dt. 20.03.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- **9043-4214-0887** under SDO elect. Dharamgarh.
- 2) As complained by the complainant that excess units were billed in the month of 10/2021 and 03/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:

- 1) PVR:28/03/2025
- 2) Bill details from: 06/2020 to 02/2025
- 3) Date of supply:10/05/2019
- 4) Category: LT/Domestic



- 5) Connected Load 1 KW
- 6) Meter No – TWSP51035795
- 7) Installed on: 28/08/2023 with IMR “0”
- 8) CMR:1230 KWH on 28/03/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO elect. Dharamgarh as follows:
 - Billing was average 06/2023 to 07/2023 and meter was installed on 28/03/2023 and billing is actual till now.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Billing was average 06/2023 to 07/2023 and meter was installed on 28/03/2023 and billing is actual till now.
- As per billing database 581 units was billed for the month of 10/2021 and 950 units was billed in the month of 03/2023, which seems to be suppressed meter reading.

ORDER

29-03-2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.


The OP is directed as follows:

- To recast the bill from 05/2019 to 03/2023 by taking IMR “0” kwh on 05/2019 and “3150” kwh on 03/2023.
- To revise the bill from 04/2023 to 07/2023 by taking six-month average consumption i.e IMR “0” kwh on 08/2023 and FMR “281” kwh on 01/2024.
- To withdraw the earlier bill revision effect on date-14/11/2022.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by April-25 the opposite party after compliance otherwise it will be treated as non-compliance.
