GIST OF THE COMPLAINT:

The complainant consumer Late Nina Bewa, Repr. By Sri Lalit Mohan Naik, At-Dabari padar, Po-Boden, Ps-Dharamgarh, Dist.- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Dharamgarh on dt. 12.11.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.04 KW having consumer no- 9043-4215-0485 SDO Elect. Dharamgarh.
- 2) As complained by the complainant that bills to be revised.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 20.11.2025
- 2) Bill details from: 12/2013 to 10/2025
- 3) Date of supply: 02.03.2012
- 4) Category: LT/ Domestic
- 5) Connected Load: 0.04 KW
- 6) Meter No – TPWODL1007805
- 7) Installed on: 05.08.2022 with IMR “0”
- 8) CMR: 7205 KWH on 20.11.2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Dharamgarh as follows:
 - Billing was actual from date of connection and 1175 units billed on 06/2016. A new meter is installed on 08/2022 and 08/2022 billing is actual till now. However, the respondent requested the forum to take appropriate decision as necessary.

FINDINGS / OBSERVATIONS OF THE FORUM



On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Billing was actual from date of connection and 1175 units billed on 06/2016. A new meter is installed on 08/2022 and 08/2022 billing is actual till now
- Some bill was served abnormally from 03/2012 to 04/2022 due to suppress meter reading.

ORDER

28.11.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 03/2012 to 04/2022 with IMR "0" kWh and FMR "5253" kWh.
- To withdraw the earlier bill revision was effect on dt-21.11.2022.
- Any adjustments made during the revision period are also be taken into consideration / DPS charged on the wrong bills are also to be withdrawn.
- The complainant must clear all dues upon revision of bills.

The case is disposed of accordingly.

The matter is closed herewith. The compliance report to be submitted to the undersigned on or before **Dt- 31.12.2025**.
