GIST OF THE COMPLAINT:

The complainant consumer Sri Bhika Mali, Repr. By Sri Sumeswar Majhi, At/Po-Raj Moter, Ps-Dharamgarh, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Dharamgarh on dt. 19.11.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1.50 KW having consumer no- 9043-4224-0538 under SDO Elect. Dharamgarh.
- 2) As complained by the complainant that the average bills were served during meter defective period.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:

4) Category: LT/Domestic

10) Facts of the complainant: Revision of bill

11) As written version submitted by SDO Elect. Dharamgarh as follows:

Billing was average from 10/2016 to 08/2022 and meter was installed on 07/02/2023 and billing is actual till now. The bill is revise at section level on 13/11/2024 and Rs. 1181.10 is withdraw.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Billing was average from 10/2016 to 08/2022 and meter was installed on 07/02/2023 and billing is actual till now. The bill is revise at section level on 13/11/2024 and Rs. 1181.10 is withdraw.
- As seen from database, bills were generated from 09/2022 to 01/2023. In the month of 02/2023 a bill was served for 200 units showing meter change and in the month of 03/2023 a bill was served for 1080 units. So it was presumed that the meter was actually changed in the month of 09/2022, so the recasting of bill should be done from 09/2022 instead of 02/2023.

ORDER 30.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 09/2022 to 10/2024 by taking IMR "0" KWH on 02/2023 and FMR "2616" KWH on 10/2024.
- To withdraw the earlier bill revision on 13/11/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
