GIST OF THE COMPLAINT:

The complainant consumer Sri Trilochan Barik, AT/Po- Sosia, Ps- Golamunda, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Dharamgarh on dt. 08.08.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9043-4225-0065 under SDO Elect. Dharamgarh.
- 2) The consumer is complaining about the bill revision during the average periods from March 2001 to March 2004 and from October 2008 to November 2023 as the line disconnection from October 2008 top August 2021 as on billing database.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from May 2001 to July 2024
- 3) Date of supply 01/01/1990
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No TWNX517387
- 7) Installed on 04/01/2024 with IMR: "0"
- 8) CMR: 760 KwH as on 11/09/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Dharamgarh as follows:
 - The consumer is complaining about the bill revision during the average periods from March 2001 to March 2004 and from October 2008 to November 2023 as the line disconnection from October 2008 to August 2021 as on billing database.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that the consumer is complaining about the bill revision during the average periods from March 2001 to March 2004 and from October 2008 to November 2023 as the line disconnection from October 2008 top August 2021 as on billing database.
- As per database from 02/2008 to 08/2008 the bill has served as defective meter.
 But the bill for the month of 11/2023 has serve for 2033 units for a month which the meter was already defective.

ORDER 30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

• To revise the bill for the month of 09/2021 to 11/2023 taking six-month average consumption of present (i.e IMR "0" KWH as on 01/2024 and FMR "591" KWH on 06/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
