GIST OF THE COMPLAINT:

The complainant consumer Sri Santanu Kumar Joshi, At/Po- Sosia, Ps- Golamunda, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Golamunda on dt. 09.01.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 2 KW having consumer no- 9043-4225-0128 under SDO Elect. Dharamgarh.
- 2) As complained by the complainant that the bill was raised during the line disconnection period.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:



11) As written version submitted by SDO Elect. Dharamgarh as follows:

• Billing was provisional during his disconnected periods from 09/2021 to 09/2024 as the consumer was not availing the electricity.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Billing was provisional during his disconnected periods from 09/2021 to 09/2024 as the consumer was not availing the electricity.
- As per billing database the bill was raised provisionally from 08/2021 to 09/2024 during the disconnection period, and SD amount was adjusted against arrear on dtd. 15.03.2024. And DPS was levied from 06/2019 to 09/2024.

ORDER 28.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To withdraw the bill excluding the fixed charges from 08/2021 to 09/2024 as the power supply was not availed by the complainant.
- ➤ To withdraw the DPS was levied from 06/2019 to 09/2024, as the complainant is domestic category.
- To demand SD amount as applicable as per regulation.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>February-25</u> the opposite party after compliance otherwise it will be treated as non-compliance.
