The complainant has appeared and submitted during course of hearing at camp court at Golamunda on dt. 04.06.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9043-4227-0810 under SDO Elect. Dharamgarh.
- 2) As complained by the complainant the1st bill was served in 4070 units in the month of 09/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings: \

- The complainant reiterated for excess billing.
- The OP submitted that billing is actual, but the line was supplied from 05/2020, and it was wrongly entry in data base was 10/2023. So, 4070 units billed on 09/2024.
- As per billing database 4070 units was billed for the month of 09/2024, which seems supress meter reading.

ORDER 26.06.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 05/2020 to 05/2025 with IMR "0" KwH on 05/2020 and FMR "4600" KwH on 05/2025.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by July-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
